



## **Update for Lyneham and Bradenstoke Parish Council October 2020**

### **Wiltshire Council**

#### **COVID-19**

Wiltshire Council is now in Recovery phase, although we are ready to spring back into action should Lockdown be reintroduced. There have been a couple of local outbreaks which have been managed in accordance with our Outbreak Management Plan.

The Wellbeing Centre number is still active but most staff have now returned to their normal posts.

Our main offices and public buildings are still closed to the public since Lockdown with the majority of our staff working from home.

We have recommenced many of our Council meetings virtually using Microsoft Teams.

We are administering a number of grant schemes on behalf of businesses.

A tool kit with a range of resources to use in the community was sent to Members and town and parish councils last week.

Lime Kiln Leisure Centre re-opened on September 7<sup>th</sup>.

RWB Library is now open under controlled measures.

Discussions are taking place about re-opening Lyneham library.

#### **My Wiltshire App**

The updated My Wiltshire App is now live.

#### **Area Boards**

Our first virtual Area Board was held on September 30<sup>th</sup>, with good feedback from local COVID response volunteers.

The focus over the next few months will be on local recovery.

#### **Parish Steward**

There have been a few difficulties with the Parish Steward scheme over the past few months. There is now a new Parish Steward in place so hopefully things will improve from here on in.

#### **Consultations**

There are no locally relevant consultations at present.

### **Local**

#### **MoD Lyneham**

Welcome to Major Iain McDavid who is the new community liaison

The new light controlled pedestrian crossing by B Site is still awaiting commissioning. It has been delayed due to a number of technical difficulties.



### **Road Issues/CATG**

Lyneham (Dauntsey) Banks road surface has become defective once again. Emergency works are planned for later this month.

The defects are primarily caused by the geology of the land, however the costs of maintaining the road are of concern to Wiltshire Council. We are considering other ways of managing the traffic on The Banks and will include public input.

A virtual CATG was held on October 7<sup>th</sup>. There are currently no Lyneham and Bradenstoke requests in the pipeline, however I have been approached by a Bradenstoke resident reference a 20mph speed limit through Bradenstoke village. This would need to be discussed by the Parish Council first, and I have advised the resident to contact the Parish Council in the first instant.

### **Police**

A local consultation was held last month in both Lyneham and Bradenstoke. The main issue raised was speeding traffic through Lyneham on the A3102.

### **Youth**

Wiltshire Council has a duty to provide Positive Leisure Activities for 13-19 year olds and provides funding through the Area Board.

The Parish Council previously co-funded youth sessions at the Community Centre using CMAS as a provider. CMAS is no longer operating in Wiltshire and these sessions have stopped. Amy Dallimore continues to provide an excellent range of activities for young people, however the Area Board is concerned particularly about young people's mental health and well being at this difficult time. We are looking to employ the Rise Trust to hold some half term Youth engagement sessions to scope out any future needs for our young people.

### **Chippenham Road area.**

The White Hart area has been tidied up.

Wiltshire Council will be sending out a team of Parish Stewards to blitz the roundabout and de-weed other areas.

No further update on the Greenfields Estate extension.

### **Lyneham Village Hall**

The Village Hall has had a condition survey done and there is a lot of work to be carried out over the next few years. I am helping the Management Committee with funding sources and linking them with local residents who have relevant expertise. If anybody knows of any funding pots that the Village Hall can tap into I am sure that they would be happy to hear from you.

### **Bradenstoke Solar Farm Community Benefit Fund**

The AGM of the BSFCBF will be held virtually on October 22<sup>nd</sup>. The most recent project funded in Lyneham is the revamped Memorial Garden which looks amazing thanks to the hard work of a small number of local residents.

### **MoD /DIO Notice to quit for private tenants**

In September, the Defence Infrastructure Organisation (DIO) gave Notice of Possession to a number of private renting tenants across the UK. The current arrangement DIO has with Annington Homes, who own the houses and lease them back to DIO, is that houses have to be handed back with vacant possession. This affects 64 homes in Lyneham.

Whilst this is a private issue between landlord and tenant, there are ramifications for Wiltshire Council as we have a responsibility to prevent homelessness.

I have been working hard with all concerned to help our residents.

Together we have pressured the DIO into extending the notice until September 2021, which gives us some breathing space to explore other options to help these residents.
