Hope you are well today and have a little time set aside to enjoy the sunshine in the garden.

It was great to meet up yesterday and I spent the evening on some upcoming plans for the area.

With regards to Bradenstoke. I have spoken with Pc Lucy Wright and PCSO Kelly Hillier and have changed their duty times around for Wednesday and Thursday in order for them to be able to attend Bradenstoke each morning for a few hours during the rush hour period. The plan at this stage is for them to take two vehicles down and provide some reassurance to local residents as well as Police any ASB and traffic breaches that they witness.

We spoke regarding a Police statement with relation to the traffic congestion in the village. I am more than happy for you to put my name to the following:

"The closure of B4069 at Lyneham Banks has caused a significant amount of disruption to both commuters and residents in the villages of Bradenstoke and Dauntsey. Temporary signage to advise road users of the closure and the associated diversion route is in place, however, we are aware of the large volumes of traffic passing through the villages during rush hour periods. This has caused some frustration within our community.

Whilst Wiltshire Highways continue to monitor the situation, residents are encouraged to report any concerns via the Wiltshire Highways / Wiltshire Police online reporting channels and are urged not to take matters into their own hands. Officers from the Wootton Bassett Neighbourhood Policing Team are conducting additional patrols in the area and this remains a local Policing priority".
