STATEMENT OF WORK GRASS CUTTING FOR LYNEHAM AND BRADENSTOKE

Areas **to be maintained**: As identified on the attached map including the sites listed below with the specification.

BRADENSTOKE SITES:

Site 1 Bradenstoke Play Park, to include dog exercise field.

- To cut all grassed areas between **fourteen to sixteen times** per year.
- All grass cuttings to be left but care to be taken not to scatter grass cuttings on any adjacent hard surface footpaths.
- To trim around any benches, trees, shrubs and other objects fixed into the ground. When strimming, care to be taken not to cause damage to trees, shrubs or other fixed objects.
- To clear any areas of brambles or other overhanging shrubbery **twice per year**.
- Weed control measures along the bottom of any fences **once per year**.

Site 2 Grass verge alongside Bradenstoke Play Park, including the ditch.

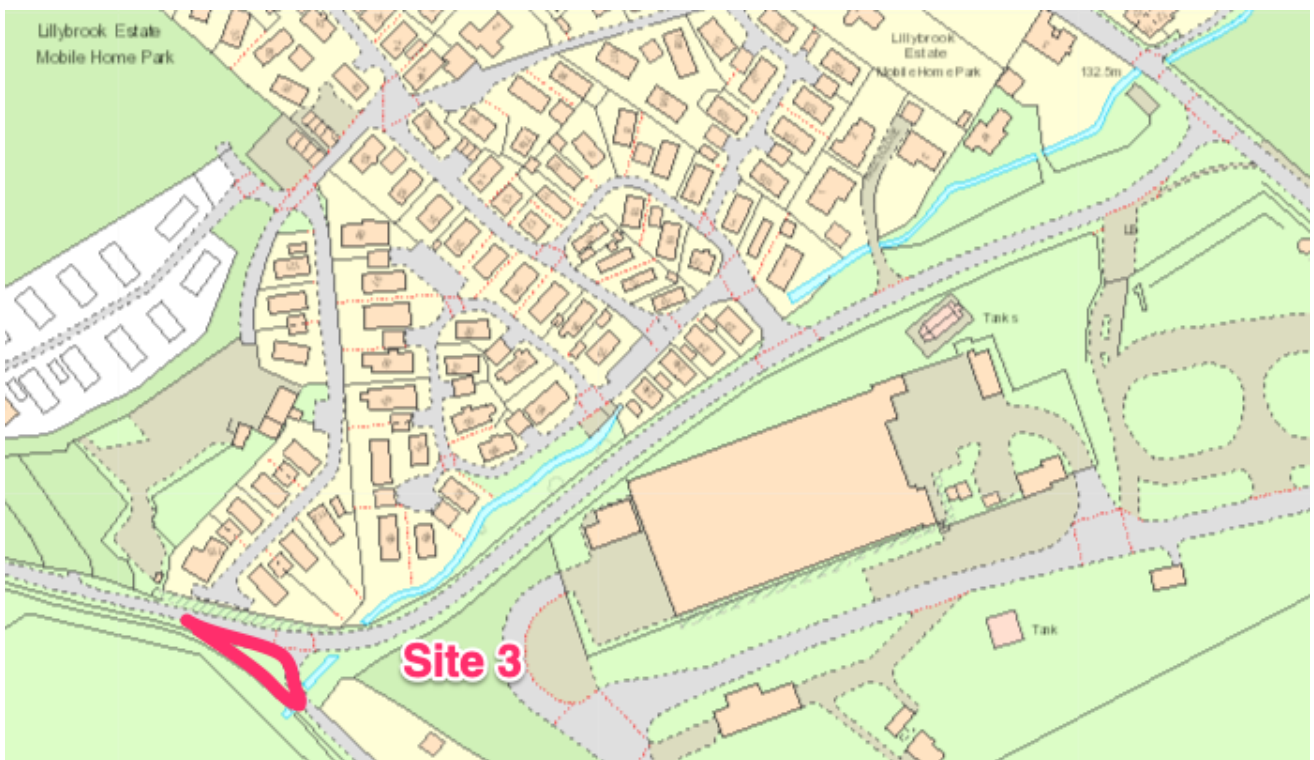
- To cut grass and clear ditch once per year in October.

Site 3 Hoppy's Corner, Bradenstoke

- To cut all grassed areas **fourteen to sixteen times** per year.
- All grass cuttings to be removed.
- To trim around any benches, trees, shrubs and other objects fixed into the ground. When strimming, care to be taken not to cause damage to trees shrubs or other fixed objects.

Site 4 Grassed Area outside dog exercise field, Bradenstoke.

- To cut grass fourteen to sixteen per year.
- All grass cuttings to be left.



LYNEHAM SITES:

Site 5 Pound Close Play Area, Lyneham.

- To cut all grassed areas **fourteen to sixteen times** per year.
- All grass cuttings to be left but care to be taken not to scatter grass cuttings on any adjacent hard surface footpaths.
- To trim around any benches, trees, shrubs and other objects fixed into the ground. When strimming care to be taken not to cause damage to trees or shrubs or other fixed objects.
- To clear any areas of brambles or other overhanging shrubbery **twice per year**.
- Weed control measures along the bottom of the fences **once per year**.

Site 6 Lyneham Green (see map)

- To cut all grassed areas **fourteen to sixteen times** per year.
- All grass cuttings to be left but care to be taken not to scatter grass cuttings on any adjacent footpaths.
- To trim around any benches, trees, shrubs and other objects fixed into the ground. When strimming care to be taken not to cause damage to trees or shrubs or other fixed objects.
- To clear any areas of brambles, nettles or other overhanging shrubbery **twice per year**.
- The small area that has been left as a wildflower meadow to be cut once per year after natural die back has occurred — all grass cuttings to be removed.

Site 7 Grassed area on bend outside Melsome Road.

- To cut grass **fourteen to sixteen times per year**.
- All grass cuttings to be left.

Site 8 Ditch adjacent to Melsome Road.

- To clear **ditch** and cut surrounding grass **once per year**.
- All grass cuttings and other arisings to be removed.

Site 9 Hedge and grass banks adjacent to the footpath outside St Michael's Church, Lyneham.

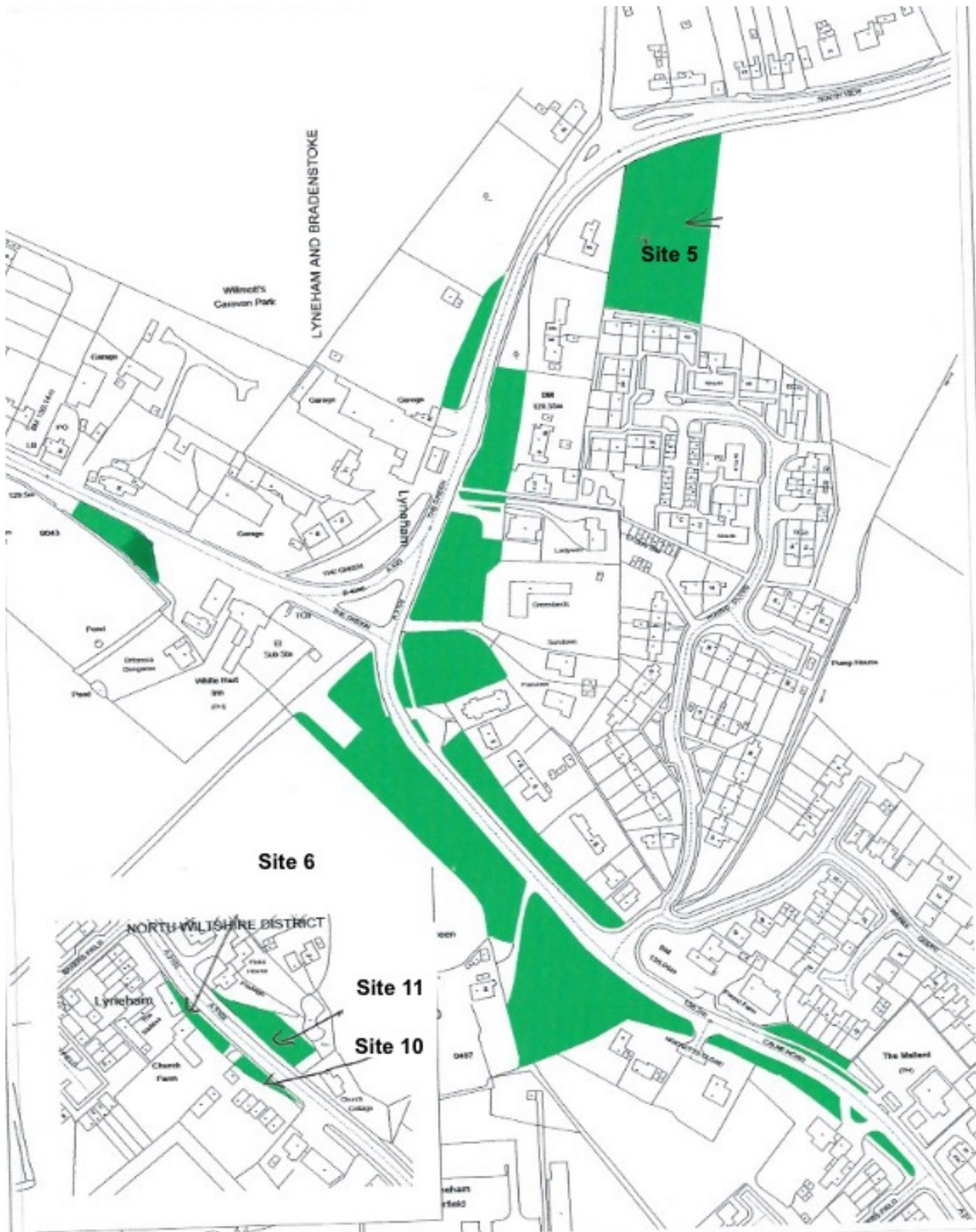
- To cut grass **bank four times per year** in April, June, July and September.
- All grass cuttings to be removed.

Site 10 Area in front of Church Farm Mews, Lyneham (see map)

- To cut grass **six times per year** in April, May, June, July, August and September.
- All grass cuttings to be left.
- To cut back any shrubbery overhanging the footpath as necessary, all arisings to be removed.

Site 11 The Green adjacent to Church Cottage, Lyneham (see map)

- Grass to be cut **fourteen to sixteen times** per year.
- All grass cuttings to be left but care to be taken not to scatter grass cuttings on any adjacent footpaths.
- Ditch at the rear of grassed area to be cleared **once per year** and arisings to be removed.



General Requirements:

- Except where it is specified that grass cuttings may be left, the contractor is responsible for removing any arisings to be removed. Care must be taken not to scatter grass cuttings on adjacent footpaths.
- Where Spring bulbs are planted in puss, not to cut until natural die back of bulbs has occurred.
- Weed control measures must be those approved by current legislation and any adjoining neighbours must be informed in advance that weed spraying is to be carried out.
- Any gates must be fastened and locked after work has been completed.
- Any damage to trees, hedges, fences or other fixed objects must be reported to the Parish Clerk within 24 hours.

Insurance:

- The Contractor must provide evidence of Public Liability insurance at the start of the contract and then each following year that the contract remains in place.

Variance:

- The Parish Council retains the right to amend. remove or add land and amend the frequency of requirement, after prior negotiation with the contractor.

Notice:

- The Parish Council may give one months notice to cease the contract in the event of unsatisfactory or uncompleted work.
