Sorry I have missed you but your emails for some reason have gone into my junk folder.

As our conversation the plan for the works is as follows.

- 1. Remove the existing timber and dispose.
- Remove the existing loose paint from the metal frame and apply a base coat to receive the black Hammerite smooth metal paint system. https://www.hammerite.co.uk/product/direct-to-galvanised-metal-paint/
- 3. Replace timber slats with new hardwood to match existing and treat with 3 coats of https://www.ronseal.com/for-garden/garden-furniture-furniture-stain/
